Dear Parent

From April 2015 schools were able to claim extra funding of up to £300 for some children aged 3 and 4. The funding can be used in any way by the school to develop the education of our very youngest children. At Shaw Wood, because we know that language and literacy skills are key to future success, we intend to use the funding to make sure that early language development is outstanding for every child.

To enable us to claim the funding parents are asked to complete the form below. The form is totally confidential and the information on it will only be used for the purpose of checking eligibility. Although completion of the form is voluntary we ask each family to complete it so that we can claim the maximum possible amount of funding to make a real difference for your child.

This form must be completed by the Parent of all children in our Nursery and returned to the school before your child's first day in Nursery.
